## **Brief content of the educational component:**

The goal is to acquaint students with the basic issues of the main sections of the lexicology course of the modern English language, including its subject and tasks, word formation, morphological and semantic structure of the English word, etymological foundations of the English vocabulary, stylistic and phraseological composition of the modern English lexical system, variants and dialects of the English language; providing an empirical sense of the close relationship between the theoretical material being studied and the material for practical seminar and independent work.

**Subject:** theoretical substantiation of the structure, semantics and functioning of the vocabulary of the modern English language in all its characteristics.

## The main tasks of studying an academic discipline are:

deepening the knowledge obtained in basic theoretical courses in linguistic disciplines in the lexicological field; development of research-analytical thinking in philological research with a special emphasis on the main goals and tasks of the lexicology of the modern English language in the context of the study of linguistic phenomena; mastering the conceptual and terminological apparatus and the use of knowledge of the lexicology of the modern English language when analyzing factual material taking into account linguistic, linguo- and cultural knowledge.

#### Prerequisites for studying the educational component:

in order to successfully master the discipline, students must use the knowledge, skills and abilities acquired during the study of the courses: History and Culture of Ukraine, Ukrainian language (for professional orientation), Philosophy, Foreign language.

#### Competencies acquired by the acquirer:

Ability to search, process and analyze information from various sources.

Ability to communicate in a foreign language.

Ability to think abstractly, analyze and synthesize.

The ability to use knowledge about language as a special sign system, its nature, functions, and levels in professional activities.

The ability to analyze dialectal and social varieties of the studied languages, to describe the sociolinquistic situation.

The ability to freely use special terminology to solve professional tasks.

## Learning outcomes according to the educational program:

Know the norms of the literary language and be able to apply them in practical activities.

Analyze linguistic units, determine their interaction and characterize linguistic phenomena and processes that cause them.

Carry out linguistic, literary and special philological analysis of texts of various styles and genres.

Collect, analyze, systematize and interpret the facts of language and speech and use them to solve complex tasks and problems in specialized areas of professional activity and/or education.

## Teaching methods, assessment forms and methods:

- 1) verbal: 1.1 traditional: explanation, story, conversation, etc.;
- 1.2 interactive (non-traditional): problem solving, discussions, etc.;
- 2) visual: method of illustrations, method of demonstrations;
- 3) practical: 3.1 traditional: practical training;
- 3.2 interactive (non-traditional): business and role-playing games, trainings, discussions, "round table", brainstorming method.

## **Evaluation system and requirements:**

#### **Everyday performance**

- 1 The everyday success of students for the performance of educational types of work in training sessions and for the performance of independent work tasks is evaluated using a four-point rating scale with subsequent transfer to a 100-point scale. During the evaluation of the everyday academic performance, all types of work provided for by the educational program are taken into account .
- **1.1** Lecture classes are evaluated by determining the quality of performance of specified tasks.
- **1.2** Practical classes are evaluated by the quality of performance of a control task or an individual task, performance and design of practical work.
- **1.3** Laboratory classes are evaluated by the quality of reports on the performance of laboratory work.
- **1.4** Seminar classes are evaluated by the quality of individual assignment/abstract.
- **2** The current performance of higher education applicants is assessed at each practical session (laboratory or seminar) on a four-point scale ("5", "4", "3", "2") and entered in the journal of academic performance.
- "excellent": the student has mastered the theoretical material flawlessly, demonstrates deep knowledge of the relevant topic or academic discipline, the main provisions;
- "good": the student has mastered the theoretical material well, has the main aspects of primary sources and recommended literature, presents it in a reasoned way; has practical skills, expresses his thoughts on certain problems, but certain inaccuracies and errors are assumed in the logic of the presentation of theoretical content or in the analysis of practical ones;

- "satisfactory": the student has basically mastered the theoretical knowledge of the academic topic or discipline, orients himself in primary sources and recommended literature, but answers unconvincingly, confuses concepts, answers additional questions uncertainly, does not have stable knowledge; when answering questions of a practical nature, reveals inaccuracy in knowledge, does not know how to evaluate facts and phenomena, connect them with the future profession;
- "unsatisfactory": the student has not mastered the educational material of the topic (discipline), does not know scientific facts, definitions, hardly orients himself in primary sources and recommended literature, lacks scientific thinking, practical skills are not formed.
   The final score for the current activity is recognized as the arithmetic mean sum of points for each lesson, for individual work, current test works according to the formula:

$$K^{nomou} = \frac{K1 + K2 + \dots + Kn}{n},$$

where  $K^{nomou}$  is the final assessment of success based on the results of current control; K1, K2, ..., Kn is evaluation of the success of the n<sup>th</sup> current control measure; n is the number of measures of current control.

Assessments are converted into points according to the calculation scale (table 1).

#### Final assessment

- **1** The exam is held after studying all topics of the discipline and is completed by students of higher education during the examination session after the end of all classroom classes.
- **2** Students of higher education who have completed all types of work prescribed by the curriculum in the discipline are admitted to the exam:
  - were present at all classroom classes (lectures, seminars, practical);
  - completed all missed classes on time:
- scored the minimum number of points for the current academic performance (at least 36 points, corresponding to the national scale "3");

If the everyday success in the discipline is lower than 36 points, the student has the opportunity to increase his current point to the minimum before the beginning of the examination session.

**3** Assessment of the knowledge of applicants when taking the exam is carried out on a 100-point scale.

Assessment of the knowledge of applicants through testing is carried out according to the following scale:

- "Excellent": at least 90% of correct answers;
- "Very good": from 82% to 89% of correct answers;
- "Good": from 74% to 81% of correct answers;
- "Satisfactory": from 67% to 73% of correct answers;
- "Satisfactory enough": from 60% to 66% of correct answers;
- "Unsatisfactory": less than 60% of correct answers.
- **4** The final grade for the academic discipline is defined as a weighted average grade that takes into account the overall grade for the current academic performance and the grade for passing the exam.
- **5** The calculation of the overall final grade for the study of an academic discipline is carried out according to the formula:

$$\Pi K^{e\kappa 3} = 0.6 \cdot K^{nomou} + 0.4 \cdot E,$$

where  $\Pi K^{e\kappa 3}$  is the final assessment of success in disciplines, the form of final control for which is an exam;

 $K^{nomou}$  is final assessment of success based on the results of current control (on a 100-point scale);

E is assessment based on the results of the exam (on a 100-point scale).

- $0.6\ i\ 0.4$  are coefficients of the ratio of points for current success and passing the exam.
- **6** For performing individual independent work and participation in scientific events, additional points are awarded to the applicants.
- **6.1** Additional points are added to the sum of points scored by the student of higher education for the current educational activity (for disciplines for which the final form of control is a test), or to the final grade in the discipline for which the final form of control is an exam.
- **6.2** The number of additional points awarded for different types of individual tasks depends on their volume and significance:
- prizes in the discipline at the international / all-Ukrainian competition of scientific student works 20 points;
- prize places in the discipline at the All-Ukrainian Olympiads 20 points;
- participation in the international / all-Ukrainian competition of scientific student works 15 points
- participation in international / all-Ukrainian scientific conferences of students and young scientists 12 points;
- participation in all-Ukrainian Olympiads in the discipline 10 points
- participation in Olympiads and scientific conferences of the KhNAHU in the discipline 5 points;
- performance of individual scientific and research (educational and research) tasks of increased complexity 5 points.
- **6.3** The number of additional points cannot exceed 20 points.
- 7 The total final grade for studying an academic discipline cannot exceed 100 points.

The overall final grade for the study of the academic discipline is determined according to the scale given in Table 2.
